- Adjourn meeting.
- Webminister ensures minutes get filed.

- Participate fully when comfortable.
- Share time, i.e. let others have a chance to talk.
- · Disagree with respect.
- If a discussion gets off topic, the Seneschal will nudge it back.
- If a discussion becomes too long, it may be moved to a future meeting.
- Votes can be yay, nope, or abstain.

 - Ensure quorum present; otherwise wait for more folks or adjourn now.

 - informal Ethereal Get-togethers began May 2020 online. These will continue on the 12th of each month until the plague has relented.

- Ethereal Get-together C on 20200712. Invited SCA neighbors as well. Lord Ant was the sole attendee; luckily for that insect, "sole" is not a pun here.
- Had 1 attendee at Get-together A & 2 at B.
- Thomas is willing to shift day & time, or provide additional get-togethers, at any time.
- Is anyone interested in hosting a future Ethereal Get-together? If so, contact Thomas.
- Neighboring SCA branches & anyone from Maine who is interested in the SCA are welcome, too.
- Topic Announcements & fyi.
 - Per BoD aka top level of SCA.org: no in-person stuff until at least Feb 1, 2021, except for small local gatherings **if** we get permission first.
 - Pronouns are a thing. "Gentlethem" in addition to "Welcome Lords & Ladies" got good reviews.
 - fyi, some areas in this agenda were intentionally left blank so they're not forgotten.
- Topic Branch Status.
 - Kingdom review on tap at end of 2020. EK granted amnesty vs required officers, since plague disrupted everybody. We need to be active & ready.
 - Requirements for a Canton = 5 people as paid members, including Seneschal + Exchequer +
 1 of next 3 officers: A&S, Herald, any Marshal. Seneschal cannot also be 1 of the other
 required officers.
 - Currently about 20 members, including officers.
 - Current officers: see table below.

- Topic Health. (e.g. plague & accessibility; recall our Seneschal is hard-of-hearing)
- Topic Meetings.
 - Fyi, last meeting notes on History page were for 20170817. Webminister added more.

- Topic Members, current. Gift memberships to <u>SCA.org</u> are available; contact the Seneschal.
- Topic Officers.
 - sub Topic Officers A&S.
 - Catiana left our boundaries on 20200430.
 - Before Catiana left she sought ideas about how this office can best serve small groups where folks have few overlapping interests, such as Wyndriche. If you get any ideas, please contact our current A&S officer.
 - Moira Browne became our A&S officer on 20200624.
 - sub Topic Officers Chatelaine.
 - Vivien de Valois will be stepping down at the end of August; she moved further South in Maine. Please thank Vivien; we wish her well. Antony Martin of Sheffield will become Chatelaine at that time; it is official once he appears on https://wyndriche.eastkingdom.org/ officers/.
 - Proposal by Seneschal to put Recruiting on hold, while we focus on current members & former members.
 - sub Topic Officers Exchequer. aka finances.
 - Google Meet limits are noted later in this document. Do we, or Thomas of Wyndriche, want to get the middle package (\$10/month/user; 100 hrs max) to allow meetings > 1 hour long after Google's courtesy period ends?
 - sub Topic Officers Seneschal, and Deputy.
 - Your seneschal has been quite busy; see old business. Kept the Deputy informed sometimes; Thomas needs to do better at that.
 - How am I doing? Feedback welcome, via any method.
 - sub Topic Officers TW Marshal.
 - Sir Cedric of Thanet posted numerous videos to FB; slings, spears, axes, & bizarre weapons are shown. Contact him directly for more info on anything TW related.

- Sir Cedric was closely involved in writing plague guidelines as well as Census questions for the entire SCA. That census took place in July 2020.
- Martial guidelines usually differ greatly from non-combat guidelines. Please watch for official announcements.
- sub Topic Officers Vacant. Anyone interested in an open position? Antony offered to mentor any volunteer for Herald.
- sub Topic Officers Webminister.
 - You don't need an official persona to get an EK Wiki page. Assistance is available.
 - Thomas will continue in this position until plague relents. We had a nibble that didn't pan out (what's a medieval phrase for that?).
 - Suggestions are welcome anytime for Topics at meetings, or on FB, etc. Contact the Webminister or Seneschal.
 - Webminister is working on some issues. Please report any trouble, or web concerns, with Wyndriche's online info to this officer.
- sub Topic Officers Reports.
 - Have all reports been submitted when due?
 - CC'ing the Seneschal is extremely helpful for getting a feel for what & how our branch is doing. It is easy to lose touch, particularly when interests don't overlap.
 - Are these reports sensitive? Came up when wondering if should be posted to website & if so how.
- Topic HowTo.
 - A link exists at EK Webministry for transitioning an office from 1 person to another.
 - Seneschal is requesting ideas for how to handle sensitive info, particularly for training of new officers.
 - Recall anti-doxx policy.
 - Recall copyright restrictions, e.g. vs music videos. https://seneschal.eastkingdom.org/news.php#copyright.

- Email help@helpdesk.eastkingdom.org for technical assistance. They can sometimes point you to other places for non-technical topics, too. • Does anyone have (Topic) additional items?
- Wrap-up
 - Person taking minutes ensures that at least the following members were present for entire **meeting**; adjourn earlier if attendance goes below that sooner. Seneschal, 1 other officer (says warranted but only Seneschal needs that for Cantons), 1 other populace member or witness.
 - To do's.
 - Topic
 - Topic HowTo. See earlier.
 - Topic Officer Webminister. On our official website, hyperlinks and formatting differ depending on how user gets to the information; needs to improve. Old meeting notes automatically download if you click on them; could end up with multiple copies; at the least warn user before downloading, at best give user a choice of that or simply viewing it.
 - Schedule next meeting.
 - Adjourn meeting.
 - Seneschal will remain available for 10 more minutes in case of "I just remembered X."
- Webminister gets notes from person taking them. Webminster posts minutes to https:// wyndriche.eastkingdom.org/history/, part of our official website; **must** include a summary of any official decisions that were made.

Online Branch Business Meetings

Local branches may hold business meetings online.

- 1. To ensure that members of the populace are able to participate, meetings should be *announced in advance using the branch's official channels* and standard means of communication. If a branch needs help communicating with their populace, contact the Kingdom Seneschal, who may enlist the assistance of the Kingdom Social Media Officer, Webministry, and other resources as necessary.
- 2. To provide visibility to those unable to attend, *minutes should be recorded and shared with the populace, including at a minimum a summary of any official decisions made.* These minutes should be made accessible to anyone who would normally be allowed to attend the meeting. Remember not to publish anyone's personal information like phone numbers or home addresses without their explicit approval. If you can record the online meeting and post it this may also be useful, if the participants consent to recording & publication.
- 3. If branches have *bylaws or customs* that govern their meetings, such as rules for convening meetings, quorums for voting, or other related policies, those *should* continue to *be followed*. If a branch needs a variance from their bylaws for some reason, contact the Kingdom Seneschal.
- 4. If a branch does not have such bylaws or customs, at a minimum at least the warranted Seneschal, one other officer, and a witness/populace member must be present on screen or in the online forum for the entire time the meeting is held in order for the meeting to be considered official.

- D. if using Google Meet: "Turn on the captioning feature"

Google Meet \$ and features, per https://apps.google.com/meet/pricing/ on 20200729:

- G Free = max 1 hr, max 100 folks (vs 25 earlier), Live captions in English only, join from browser (not phone), recording NOT saved to G Drive (so ? to where). This is used by SCA.
- G suite = \$10/user/month, free gets it thru Sept 30, max 300 hrs, max 150 folks, adds join from phone.
- G enterprise = \$20/user/month, max 250 folks, adds recordings saved to G Drive and some "coming soon" features.

Didn't include security & support features for these packages above. All include encryption.

To do after Sept 30 = try join by phone & > hr meeting after Sept 30 & review G Meet pricing website; reminder is on Thomas' iCalendar.
